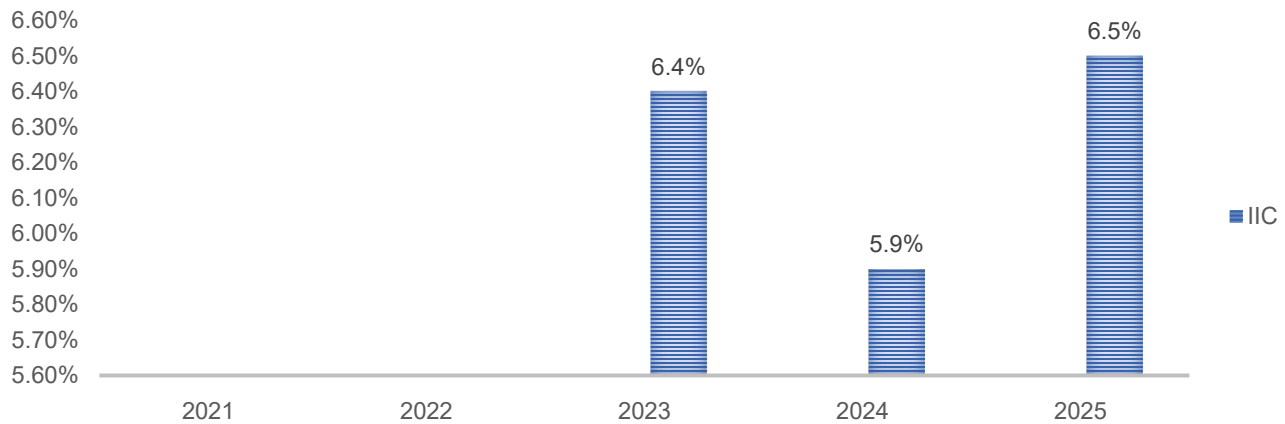
Rentabilidad histórica
